1 2 INTERSTATE MEDICAL LICENSURE COMPACT COMMISSION Notice of public hearing on rule proposed for adoption -- Chapter 2, "Information 3 Practices" 4 5 Pursuant to the authority of Sections 8 and 15 of the Interstate Medical Licensure Compact, 6 the Interstate Medical Licensure Compact Commission (IMLC Commission) hereby proposes to 7 adopt administrative rule Chapter 2, "Information Practices." 8 9 The purpose of Chapter 2 is to establish information practices to facilitate member states' information collection and sharing through the IMLC Commission. The chapter defines a core 10 11 data set and provides that the IMLC Commission is prohibited from providing any and all information maintained in the IMLC Commission's coordinated information system to any 12 individual, entity or organization other than a member state board. 13 14 The IMLC Commission approved this notice of intended action during a teleconference meeting on November 7, 2016. The IMLC Commission will consider the rule for adoption at a 15 teleconference meeting on December 14, 2016. 16 Any interested person may present written comments on the proposed rule not later than 5 17 p.m. Eastern Standard Time on November 28, 2016. 25 teleconference should notify Mark Bowden at (515) 242-3268 or mark.bowden@iowa.gov by 26 November 23, 2016. 27 The following rule is proposed for adoption: 28 2.0 Information Practices. 29 **2.1 Authority.** This chapter is promulgated by the Interstate Commission pursuant to the 30 Interstate Medical Licensure Compact. This rule shall become effective upon adoption by the 31 Interstate Commission. 32 33 2.2 Definitions. 34 "Coordinated information system" means the database established and maintained by the 35 36 Interstate Commission as set forth in the Compact. "Core data set" means a set of information about an applicant for a letter of qualification for 37 expedited licensure through the Compact or a set of information about a physician who is issued 38 39 an expedited license through the Compact or renews an expedited license through the Compact. The core data set shall include: 40 1. Eligibility for expedited licensure through the Compact; 41 2. Full legal name; 42 3. Other name(s) used, previously or currently; 43 4. Gender; 44 5. Date of birth; 45 6. National Provider Identifier Number;

7. Social security number;

49	9. Telephone number of record;
50	10. E-mail address delegated by applicant to receive correspondence;
51	11. Medical degree conferred;
52	12. Medical school, including year of completion, and verification of accreditation;
53	13. Residency program, including year of completion, and verification of accreditation;
54	14. Specialty board certification, including date of issue and expiration date, if any;
55	15. The license number, date of issue, and expiration date of the full, unrestricted medical
56	license issued by state of principal license;
57	16. The license number, date of issue, and expiration date of the expedited license issued by
58	a member state;
59	17. The license number, date of issue, and expiration date of the license renewed by a
60	member state.

62	"Expedited license" means a full and unrestricted medical license promptly issued by a member
63	state to an eligible applicant through the process set forth in the Compact and its administrative
64	rules.
65	"Letter of qualification" means a notification issued by a state of principal license that expresses
66	an applicant's eligibility or ineligibility for expedited licensure through the processes set forth in
67	the Compact and its administrative rules.

69	2.3 Collection and dissemination of core data set.

8. Address of record;

- 2.3(1) The core data set is collected from the applicant by the state of principal license through
 the expedited licensure process set forth in administrative rule 5.5.

- a. The state of principal license shall submit an applicant's core data set to the Interstate

 Commission when the state of principal license issues a letter of qualification, verifying

 or denying the applicant's eligibility for expedited licensure through the compact.
- b. The Interstate Commission shall maintain an applicant's core data set in a coordinated
 information system established and maintained by the Interstate Commission.
 - c. The Interstate Commission shall distribute an applicant's core data set to all member states that issue an expedited license to the applicant.
 - d. The Interstate Commission shall make available to any member state the core data set of an applicant for a letter of qualification or a physician who is issued an expedited license through the Compact.
 - **2.3(2)** A member state, using a form provided by the Interstate Commission, shall collect, verify and provide to the Interstate Commission the following information for inclusion in the core data set for each physician who is issued an expedited license by the member state:
- a. The license number, date of issue, and expiration date of the full, unrestricted medical
 license issued by the member state.
- 2.3(3) A member state, using a form provided by the Interstate Commission, shall collect, verify and provide to the Interstate Commission the following information for inclusion in the core data set for each physician who renews an expedited license issued by the member state:
- a. The license number, date of issue, and expiration date of the full, unrestricted medical
 license issued by the member state.

- **2.4(1)** The accuracy of information maintained in a core data set, to the extent it is possible to achieve accuracy through the expedited licensure process and licensure renewal process, shall be the responsibility of member states.
- a. A state of principal license or any member state shall verify and submit to the Interstate

 Commission an amendment to correct a core data set of an applicant for a letter of

 qualification or a physician who is issued an expedited license through the Compact.

 Upon receipt of information from a member state to correct core data, the Interstate

 Commission shall disseminate a notice to all member states that a core data set has been amended.

2.5 Availability of information in coordinated information system.

2.5(1) The Interstate Commission is prohibited by the Compact from providing any and all licensure, complaint, disciplinary and investigatory information maintained in the coordinated information system, including a core data set, to any individual, entity or organization other than a member state board.
